- 18:23:19 The meeting was attended via zoom by panel members Jacome green Lopez on Shepherd tech around town myself. The meeting was open to the public via online live stream.
- 18:23:31 It is recommendation committee that contract items one through 21 be considered into resolutions resolution one item one resolution two items 20 items two through 21, and thank you.
- 18:23:50 Okay, thank you so much.

- 18:23:53 Councilmember before. Well, thank you.
- 18:23:59 Yeah.
- 18:23:59 Before we begin this Mandela, Interim acting senior executive director of contracts and purchasing and chief MWD officer, do you have any remarks to share, regarding these contract items, and can chair green.
- 18:24:14 Again, in an effort to streamline this meeting, I'm not going to do my standard preamble which was announced at our contracts committee. However, I do want to say that I would like to note that the panel has been provided with technical changes to contracts
- 18:24:26 approved at prior meetings, and these changes have been posted to the web. And I'll turn it back over to you sharing
- 18:24:42 to thank you chair green resolutions over approval this evening are all entitled resolution regarding approval of contracts, and as indicated by a contracts committee chair Faulkner resolution one consists of contract item one resolution to consists of
- 18:25:00 items two through 21 and panel members please note if you wish to vote differently for a specific contract item within resolution to, you may do so, simply indicate as much when the roll call vote is taken.

- 18:27:41 This is school utilization, we will add you to the school utilization list but this is for contracts.
- 18:27:50 Then it's for the contracts I apologize, I was going off of the agenda.
- 18:27:55 Bear with me I do have something regarding that it is regarding a contract. I'm not sure which number it is on your resolution, but it is to purchase or budget for console consultants to be used.
- 18:28:53 But I think that that money could be directly used to be able to pay out.
- 18:28:44 Providers directly, and maybe even long term. I think we need to start incentivizing, those that work within the Department of Education to create long lasting meaningful impact on our students.
- 18:28:53 Thank you.
- 18:28:57 Thank you.
- 18:28:59 The next speaker on contracts is <u>Leona Henderson</u>Leonie <u>Haimson</u>, your audio and video enabled, please unmute.
- 18:29:13 Good evening, everyone. My name is <u>Laney HampsonLeonie Haimson</u> I'm the executive director of class size matters, a nonprofit that provides information on the benefits of smaller classes and also provides critical oversight when it comes to the D<u>OE</u> budget.
- 18:29:27 Hello Chancellor and welcome to the new members of the PAPPEP, we'd like to point out that your contact information is still not posted on the website, which is unfortunate because you're supposed to be public servants with whom members of the public can
- 18:29:38 get in touch, to share resources information and concerns. We strongly hope that you will provide better oversight than previous panels which too often have rubber stamped contracts which were found to be corrupt and are wasteful to the tune of hundreds
- 18:29:51 of millions of dollars. In one case, along with in public advocate Tish James, we blew the whistle on a deal we contract for computer wiring proposed at 1.1 billion over five years renewable at \$2 billion to a contractor who had been engaged in a massive
- 18:30:06 kickback scheme, just a few years before, yet the panel voted tend to one to approve the contract anyway. Thankfully due to the ensuing scan...[At this point the PEP chair interrupted and tried to cut me off, saying something about how this wasn't relevant to the contracts at hand].

18:30:16 <u>I am speaking</u> about the contract process in general, my associate will talk about this individual contract number one, that will be spoken about tonight.

18:30:32 Thankfully due to the ensuing scandals City Hall rejected and it was repeated to savings of \$163 to \$620 \$7 million as a response to the scandal. From then on, the DOE_that God_promised to post all information about proposed contracts at least one month ahead to allow the PEP

18:30:47 the public and elected officials to carefully scrutinize them and ask relevant questions, yet the deal-DOE we stopped doing this in April 2022 years ago, I hope that you wantwill insist says that it happens once again.

18:30:59 Finally a state law was passed in 2005 requiring all school board members to receive at least six hours of training and in financial oversight. According to PEP members over several administration's this training is has never been provided in violation of state

18:31:12 law. I hope you will insist on such training in order to help you perform your responsibilities to minimize waste and fraud, as so often is occurred in the past.

18:31:54 For more information on these issues and what the law requires feel free to reach out to us at info at class size matters. org, and my associate Michael grants Rance will speak specifically to contract number one.

18:31:54 Thank you very much.

18:31:54 Thank you.

18:31:54 The next speaker.

18:32:12 Speaker for contracts is Michael RamsRance. Please unmute yourself.

18:31:51 Great, thank you so much Rebecca. Hello everyone, my name is Michael rants Rance and I am also from class size matters. And today's meeting. Among the many contracts to be voted on is for a company called 22nd century technologies.

18:32:05 At \$16.5 million per year in renewable for five years at \$82.5. million.

18:32:11 The proposal says that the company will be paid to hire and manage quote-"consultants in a wide range of disciplines across documents weDOE schools and offices" and quote, and will charge <a href="quote-"quote

18:32:28 Per deal we referred and vendor recruited consultants, respectively," and quote, costing the city millions of dollars.

18:32:33 There's little information in the proposal as to what these consultants will actually do, where they will be placed. And why do <u>DOE</u> employees cannot perform the same services at less expense to the taxpayer.

18:32:46 Even if the y use of consultants is advisable, which we doubt, there is no reason why the deal <u>DOE</u> we cannot hire and manage them directly, without paying these expensive <u>market-mark-up prices.</u>

18:32:57 Chancellor David banks has repeatedly said he wants to cut waste and bureaucracy. If so, this contract is a strange way to go about doing it.

18:33:07 The <u>deal heDOE</u> has also promised that <u>quote</u> "any document reference in this era will be <u>promoted provided</u> to <u>PTP PEP</u> members upon request, <u>unquote</u>", but in the past, when panel members have asked to see the <u>m such as the</u> actual <u>post proposed</u> contracts.

18:33:21 They have routinely been refused.

18:33:23 Given this lack of transparency and no substantive explanation about why this contract is needed at this time, we encourage <u>the members of the PEPthem numbers have to pee pee pee</u>, to ask hard questions about it.

18:33:35 And if the answers do not satisfy you. to vote no. R, remember every dollar you approve is one less dollar that can be spent in the classroom, providing a quality education to in New York City children.

18:33:46 Thank you.

18:33:50 Thank you.

18:33:53 There's no one else who signed up in the zoom so we will now check in with our language rooms.

18:36:09 But I do think that we do the general public a disservice.

18:36:14 When we discuss a contract worth \$82 million.

18:36:23 And, you know, with almost no conversation.

18:36:29 I remember during the contracts committee meeting, asking for specific questions around.

18:36:41 You know how this money was going to be spent like, which contract like who you hiring Who are you, employing with this right. And you know I receive nothing until about, maybe an hour and a half ago.

18:36:58 And that in itself raises some serious concerns for me because it sets me up to have absolutely no time to scrutinize, or even review in any sort of like substantive way.

18:37:16 The documents that were presented to me.

18:37:18 And when I consider that, and I could end and just the uneasy feeling I get around this because I don't know how this \$82 million is going to be spent and on who and for how long.

18:37:35 And the fact that you have an agency that's basically taken what 18% off the top.

18:37:43 I am inclined, and will vote no on this, on on resolution number one.

18:37:51 The remaining resolutions. I also have an issue with the fact that we have also historically broken these issues out into buckets, so that the general public could also understand what it is we were voting on and what they meant.

18:38:12 And, you know, tonight we got absolutely none of that. So I am also very concerned about that, although I have no specific issue with those contract items.

18:38:25 Thank you I you back.

18:38:29 Thank you. Anyone else have a comment.

18:38:36 Sir,

18:38:36 and debt. Deb [Dillingham].

18:38:39 I do.

18:38:41 Yeah, I just want to echo Tom.

18:38:45 In that we did request additional information at the contracts meeting.

18:38:52 I know I didn't receive any follow up, either.

18:38:58 So, you know, I just want to echo that that happened.

18:39:05 And I'm just wondering, actually, on this particular contract is number one, if indeed we don't know what the money is going to be spent on specifically if there is any urgency in passing on this contract this evening or could we push it to next month.

18:39:28 So that's a question I guess from Lindsey.

18:39:32 Is that a question for you, Linda.

18:39:35 Sure. Hi done. I.

18:39:39 Sure. So, the request for authorization, that was posted 10 days ago and discussed during our briefing The day after it was posted and during our contracts committee meeting last Friday does include the breakout of the \$16 million a year, that is being

18:39:55 proposed as the maximum out under this contract. So, about \$9 million that 16 million, which is all of this is based on historical spending with is, is spent directly out of school budgets at the discretion of the principal to support school based activities.

18:40:12 The other activities are funded by stimulus dollars that relate to the temporary nature of the stimulus funding, as well as other types of usage. So it's outlined there and we discussed.

18:40:27 When we met.

18:40:28 Like I said before, some of the specific activities that schools and central offices use for this. So this contract is useful for the Department of Education to support, things like the Situation Room surging in staff at our call centers during the first

18:40:45 month of school.

18:40:48 This contract help us staff the rec centers that ran during the pandemic and other types of outreach and marketing campaigns that we have run for a number of other usages and schools.

18:41:03 And so, this is a contract that's useful for us, the markup, that has been mentioned tonight is around 17%. And that is an administrative overhead fee that's being paid for additional activities that this vendor is providing for us, it's not just pure

18:41:23 profit that this vendor is making this is for the paychecks that they are printing for these vendors for managing the employees that are working for them and those types of other activities.

18:41:36 So those are those are some of the administrative overhead costs that are being paid for by that Nick can certainly speak a little bit more to that if I've missed other key activities there.

18:41:45 I want to also flag that this is an \$82 million award over five years to a certified MWBE vendor. And we think that that's a great thing. And we want to support I know many of you on the panel have are interested in that and we're proud of the fact that

18:42:02 this is an MWV vendor and Nick can speak more to that too and his role, but really just want to emphasize that this is a contract that's useful for us.

18:42:13 If this contract were delayed, this is a, this is the scope of services where this is a new vendor that we are awarding pursuant to a competitive RFP.

18:42:22 And so if this contract were delayed, we would have a lapse in service, and we're really trying to prevent a lapse in service to our schools into our other parts of our community to make sure that we don't negatively impacts the employees who are working

18:42:37 for this, this vendor, and that we don't have an interruption of services.

18:42:45 I hope that was helpful and if Nick if I miss anything critical please jump in.

18:42:50 No, I mean I think that generally covers it Oh sorry, go ahead.

18:42:54 I just want to say thank you Lindsay.

18:42:56 You're welcome.

18:42:59 Thank you, Lindsay, I see our panel member talk around say, Do you have a question you'd like to ask.

18:43:07 Thank you. Thank you so much, Dr Greene and thank you Lindsay for the breakdown and, you know, certainly, as one of the first Native American MW bees in New York City.

18:43:20 I take the term MWBE very serious, but I also take the just baseline and distribution of funds for any contract, extremely serious. And so for me just even in reviewing the agenda items, and the documents that Nick, you are so kind to distribute a couple

18:43:40 of hours ago to us, it's, it's just a little too vague for me.

18:43:44 And I always come with the business hat first and then also being a mother and so in the business world, when you present a contract you have scope of deliverables, you have a timeline.

18:43:57 And then you also kind of have your return on investment and your response for the client and so in this case that would be the DOE, and the 9 million that was broken down I understand that it's 82 million over five years, but the 9 million that was broken

18:44:15 down, it was a little too vague and so, Lindsay I would love to see a true, or an outline of how this is planning to be distributed to communities, whether it's through marketing whether it's through after school programs etc etc that you mentioned, because

18:44:33 that could be a gamut of resources that are out there but I'd like to see this across all schools. And so although I am pleased that it is an MWB. The other issue that I have is that there were only six RFP responses in New York City.

18:44:52 we have over 2000 mW bees and neck and I, we have discussed this along with Tom.

18:44:59 And even with SBA talking about not only just bringing those numbers up but what does that mean what is the value of that mean. And so for me when I see that there's only six RFP responses.

18:45:11 That's not sufficient enough. And that's just my personal opinion.

18:45:17 But, in regards to resolution, item number one, I'm having a really hard time reviewing this and I have to agree with some of the comments that were presented.

18:45:28 Previously, so that's all that I have to say on that.

18:45:35 Thank you. Thank you so much.

18:45:38 panel member, talk about today, and a panel member Zod, welcome. And would you like to ask a question.

18:48:35 This is not a contract that was left for curriculum development, this is the contract that was led to provide short term staffing.

18:48:45 To access to short term staffing and support for those staff to support a variety of projects. There is nothing in this contract that mandates that schools use them, that mandates that central offices use them or mandates any specific scope of work.

18:48:59 This is a contract that central offices and schools will have access to at their choice. So I just want to make sure that was clear.

18:49:08 This isn't a project based or the scope of work based contract past just the fact that it is a contract that will provide temporary staffing to the deal we just support a variety of activities.

18:49:19 What we listed in a request for authorization are examples of how those temporary staff have supported the do in the past, they may or may not be used to support those activities in the future, and largely the activities that this contract, the stuff

18:49:34 that would be accessed through this contract would support are based on principles needs and what the school community needs since most of this contract is actually something that is accessed by school budgets and that's those are decisions that are made

18:49:47 in school communities. I hope that was helpful, I just wanted to make sure that that was clear, so that folks maybe understand this a little better.

19:08:39 And her appointment to the panel district 22 is proud to lead, one of the brightest most compassionate advocates, we have to the panel and I hope she serves all of the city well okay tonight I'm speaking on the proposed colocation, and resolution number

19:08:57 two which is in District 22 that would be ps 203 771.

19:09:05 We've known for years that we need, we desperately need more d 75 seats within district 22. And so we are, I am pleased that it is the time has come to facilitate those seats.

19:09:24 However, there, there are a few.

19:09:27 We have a few apprehensions, I can't give you a yes please vote for this or an emphatic No, do not vote for this, and the reasons are a little bit nuanced.

19:09:41 For one thing, we know that these seats will only accommodate students with autism spectrum disorder. And one of our hopes, one of my hopes was that any seats coming in are the majority of seats coming in would be able to accommodate children of all disabilities,

19:09:57 and with all kinds of specialized learning needs.

19:10:02 I'm sorry I have gold.

19:10:06 So we hope that there will be seats available in the future however we know also that PS two or three is the only known Do you facility that can accommodate any seats.

19:10:21 At this time, So we would like to see actual building schools built that can really accommodate children with specialized learning needs and district 22 and the Office of District planning did fulfill all of their requirements to engage with the community.

19:10:41 But as we continue to adjust to the circumstances of code restrictions, the announcement of changes felt confused and rushed especially for the families at two or three, who are trying to find their way back into a normal pace this school year.

19:11:06 I am also a member of cc of the 22 as just said, We are in favor, absolute favor of having the 75 seats available to the students within our district.

19:11:23 We are grateful that the daily is looking to accommodate those kids, but at this particular school at PS two or three while it is technically underutilized classrooms are seeing overcrowding to the tune of over 30 children in a single classroom.

19:11:45 So there is an empty floor, but on the floor is below it.

- 19:11:49 classrooms are completely overcrowded.
- 19:11:52 So, yes, we want to see more.
- 19:11:56 The 75 Kids accommodated within our district, but we don't want the needs of PS two or three students to continue to be drowned out and ignored.
- 19:12:07 Yes, we are in favor of a colocation where administration's can uplift and cooperate and work together and create a school that is great for all of their kids in both schools, but we want to be sure that the kids at a school like PS two or three have
- 19:12:28 the opportunity to have a smaller class sizes as their colleagues in the D 75 School upstairs.
- 19:12:36 So we asked the PP to expand the small class size incentive, and to provide the schools like PS two or three the funds they need to hire more teachers and decrease their class sizes.

- 19:12:53 The next speaker is Mary bill Gonzales, please unmute.
- 19:12:59 Good evening, I'm here to speak on the proposal for district 75 reciting and colocation in X 104.

- 19:13:43 We're here, and hoping to get more into 75 schools in our district, because we're so much needed.
- 19:13:38 And we're here to support our families, all the way. So, even though we know we have parents who are a little bit apprehensive about it when they hear the 75 right away you know their, their minds go crazy, but cc nine is a big support of the reciting
- 19:13:57 of the 75 two x one and four so
- 19:14:01 that's all I want to thank you.
- 19:14:06 Thank you.
- 19:14:08 The next speaker is Miriam chick who I do not see here by that name. If you are here under a different name please let us know in the q amp a.
- 19:14:19 So move on to Amy side please unmute yourself.
- 19:14:25 Good evening, cancer and the members of the panel policy.
- 19:14:31 Green.
- 19:14:31 My name is Amy sky I am a citywide community citywide Council for district 75 council member, and also the co chair of our utilization committee.
- 19:14:44 We want to really just appreciate district planning and all the CCS and all the community leaders, and all of the six proposals tonight and multiple resolutions.

- 19:14:57 We understand that it is very difficult to have these robust conversations and bring students that are special populations.
- 19:15:07 Sometimes people refer that students in districts have behavioral issues or have autism. That may not parallel with their vision or mission of their school but we appreciate the robust conversations questions and concerns that was brought up.
- 19:15:25 Again, we're really hope in speaking for my teachers and my community that all of our district 25, students will eventually be able to participate, attend and be present at schools that are in their district that they decided, as well as their neighboring
- 19:15:41 school districts so that they do not have to travel so far on a school bus. And again, to receive their services and support that they do need under the individual educational plan.
- 19:15:54 We really appreciate all the principles who are very welcoming the staff that really do understand the needs of the students need in order to thrive and have in dependency so again thank you for the opportunity to see me to represent my community and
- 19:16:10 hopefully you're all as well favor into these proposals. Thank you. Have a good day.

- 19:16:18 The next speaker is Ellen McHugh, please unmute yourself.
- 19:16:22 Hi, good evening.
- 19:16:24 Thank you for the opportunity to speak, and welcome to those new and returning members of the EP.
- 19:16:32 I am talking in general about the process of a colocation, and also the development of the plan.
- 19:16:40 In a colocation for a charter school. There must be a building Planning Council, and a colocation for district 75 schools, there's no such requirement.
- 19:16:59 As a result, we often see separate schools, not communicating with one another. As a matter of fact someone mentioned that the district 75 school would be isolated.
- 19:17:06 On the top or the empty floor, just doesn't promote a whole lot of communication, and it certainly doesn't promote a whole lot of cooperation between staff at both schools.
- 19:17:19 The other issue that comes out of this forced separation is the statement that one person made about their mind, the parents minds go crazy.
- 19:17:32 My son is a graduate of the public school system.
- 19:17:37 We have gone through many many, the 75 real relocations. It is indeed disheartening to realize that this artificial separation allows families to be afraid of District 75 students to be afraid of who they are.
- 19:17:58 Not to say that the people are mean or cruel. But the general population being afraid will certainly not help these children, integrate into society, I want to remind everyone that the children are in District 75 program for about five hours a day, the

- 19:18:16 rest of the time they are in their community with brothers and sisters attending church going to stores, playing on teams.
- 19:18:26 Being part of a community that can sometimes be overwhelming, but it certainly welcome me.
- 19:18:34 I hope that in the future. When plans occur. It will be a cooperative, or it will be a requirement to have a building. Use it to have a building cooperation, so that there isn't this minds go crazy effect.
- 19:18:55 Thank you. Thank you.
- 19:18:57 The next speaker is fe Zachary your audio and video is enabled please unmute.
- 19:19:03 Good evening everybody. I want to chime in a little bit of what Elon Musk you just said then prior to her Holly Ellis. I'm not going to speak directly to these projects with more in general projects related to what is currently discussed.
- 19:19:18 I am on the CCA jazz the city wide Council for high school I'm the co chair of the capital plan Committee, which is where basically the SCA comes to us with all the presentations of all the changes colocation join public hearings and all these things
- 19:19:33 regarding High School. So I've been to many of these hearings so far.
- 19:19:39 Regarding district, 72 and in general and kind of colocation. I think it's very important for the different schools in the same building when they're co located to work together, and we noticed that a lot of times there's a disconnect.
- 19:19:53 So I just want to emphasize how important whenever there's a plan to make sure that all parties are working together, especially when the sharing a building, and they have Capital Planning requests that come to our committee.
- 19:20:05 The same building should have similar requests because there's sharing similar resources, the same resources in many cases.
- 19:20:12 The other thing I wanted to mention and to let the members, be aware is that I'm a little bit puzzled how the district 75 seats, get allocated.
- 19:20:29 It seems like they just pick a percentage, out of the blue, and instead of being a dynamic number that depends on need. It's kind of set in stone. Sometimes there are not enough seats.
- 19:20:31 Sometimes there are too many. For example in District 26 in Queens. I believe that they are close to 600 seats I located the district 75, but only 102 of them actually use, and there's almost 500 empty seats that the SCA kind of claims are available,
- 19:20:49 but they're not really available, unless we have another 500 students coming into this 65. They published numbers that they are available. And it looks like it's available to the general population but these numbers are not.
- 19:21:01 And I'm wondering if we have so many empty seats, why not use them in a very overcrowded district why they're just sitting there empty, we can have 100 reserved maybe so we can have doubled the number of districts only five seats available, but but make

19:21:14 whatever is available to the students who do need to use them and also backwards if you need more seats for district 35. This should also be available and not limited.

19:21:22 The last thing I wanted to say about the SCA is that very recently they seem to have made revisions to the blue book without any kind of notice, and magically, a lot of school suddenly have hundreds of extra seats available to them, which is kind of busting

19:21:38 interesting, especially because their formulas indicate that they are doing smaller class size. How do you have a smaller class size, and hundreds of extra seats suddenly available in almost every school without building any construction, it seems like

19:21:51 in Queens for example that needed seats when according to them from over 10,000 to right now 4526, just for everybody to be aware, thank you very much.

- 19:25:21 Specifically, the new location at K two or three. It's not set in stone yet, in terms of what schools are going there.
- 19:25:29 My the principle that I, my door isn't an inclusion program.

20:28:37 I want to point out that just in the past two weeks since the maps mandate was lifted for K enough K through 12. We have seen an uptick of up to double the cases in certain schools.

20:28:53 51% increase just in Manhattan just in this past week, and 1,000% sewer water, please consider the kids when, and the most vulnerable, please include me think.

20:30:59 many of our students do not feel safe. And this rural takedown was an inflection point for our schools, particularly for our community and district 15.

20:31:10 And as the CC representative earlier illuminated for us.

20:31:15 Even after this finding that they have violated Chancellor statutes, we have seen absolutely no indication that there's been accountability for these administrators to remain in place and remain in a position where they are continuing to make our students

20:31:29 and our parents and community feel unsafe.

20:31:32 Last year we have the opportunity to to meet with and talk to the first step of the Chancellor Mr Conyers and we very much look forward to repeating that with the new administration and hope we can count on your support as we move forward with them you'll

20:31:44 Justice Project.

20:31:46 Thank you so much.

20:33:50 We waited for seven months for results of an investigation into these two principles tearing down a mural that six diverse children created to share their vision of racial and social justice investigation found both principles were in fact in violation

20:34:04 of regulation 830 that prohibits discrimination but still the community has not received any repair, transparency, none of our assets have been honored and we're being told that we should all just move on.

20:34:16 But, there hasn't been accountability, there's been zero restorative justice which is so often touted by the DMV, and it's not acceptable because children cannot feel safe and teachers cannot teach effectively in that kind of toxic environment.

20:34:28 What is the point of any of the claims of anti racism or cultural responsiveness or trauma informed practices. If a trauma informed community is left mired in an unsafe unhealthy environment so we need real community driven action now.

20:49:57 I spent hundreds of hours reading the resolutions, and the letters from countless education councils and community organizations, and spent almost as much time visiting schools, meeting with people and fighting to improve and save schools, and as best

20:50:14 I could use the voice and vote I have on this board to the best of my ability to represent the majority of voices and experiences of the families of this city.

20:50:28 Now this process hasn't been easy for us as a community.

20:50:32 I fully acknowledge this space has been challenging for you, the community to navigate. As students, families, and communities. I understand the frustration you feel, putting the extraordinary and exhausting work of elevating issues of equity and basic

20:50:50 human dignity.

20:50:52 I was there, while you will all sitting on countless committees and working groups for years. While this system literally ignored the work that came out of those spaces.

20:51:03 I was there in the streets protesting with you as you demanded that the system provide the basic tools necessary for our children to receive a sound basic education, like technology broadband access and a bus ride to and from school and I was with you,

20:52:52 That's the reason why I will not support and will vigorously oppose any effort to diminish parent voice over the last two years, there have been a number of people who felt it was necessary to hit me over the head with the parents that I represent, and

20:53:09 the parents I don't.

20:53:14 So to clear up any misunderstanding. I represent those parents whose voices are unheard.

20:53:19 I represent the parents who are unheard because nobody is speaking their language. I represent the parents who are unheard at the years of their children with disabilities not receiving the transportation and related services they have a right to.

20:53:34 I represent the unheard parents whose children have suffered through it, unimaginable trauma and loss and trying to find their way back at the two years in this pandemic.

20:53:44 I represent on her parents who took it to the streets to save their school when it was on the chopping block and unheard parents who send their children to a school covenant scaffolding for over a decade, and with no hot running water for six years.

20:54:00 I represent the on her parents with students in temporary housing, who have been essentially cut off from an education for two years. I represent on her parents who have to file lawsuits for their children to receive a remote education.

20:54:15 I represent those parents who have been subjected to almost constant harassment by other parents who want to maintain the status quo. And I represent, parents, that had been literally subjected to physical violence, because of their race, ethnicity, sexual

20:54:32 orientation and gender identity. I represent those parents. In other words, I represent most parents in this city.

20:54:41 I'm saying all this because the parent participation in this process is needed for a truly responsive school system that equitably educates our young people and values the lived experiences, we bring us parents and advocates for our children, my lived

20:54:58 experience has shown me that we operate in a system that claims to value parent voice, but also actively works to limit that voice, while offering few opportunities for meaningful parent participation in the process of defining what education looks like

20:55:14 for our children.

20:55:16 I'm choosing my words very carefully, because I'm making the distinction between parent engagement and parent participation. The degree to which parents are engaged depends on who defines it while parent participation in the decision making process is

20:55:32 defined by New York State Education Law. In my opinion, any system of school governance that seeks to actively limit parent voice and parent participation must be dismantled or at a minimum, tweet, by law in statute in a way that ensures that it is both

20:55:50 responsive and accountable to the students and family for which it serves. I will close by saying, if it hasn't worked in 20 years, there's no good reason to believe.

20:56:03 Continuing with the same system will produce different results. Now, I'm not saying any of this. And please believe me when I say this to appear difficult to work with, or because I have some other agenda.

20:56:16 In fact, the opposite is true.

20:56:19 I say everything I do not out of malice or ill will. But out of a profound love I have for the city that I call home. And the beautiful people in it, and out of a desire to see the future for my children, filled with more possibility, than I could have
